#### NOTIFICATION

Subject: The Jammu and Kashmir Central Inspection System (JKCIS).

- For a proficient business environment, synergy in inspections of various agencies regulating business is necessary to ensure that all relevant risks are properly addressed during inspection process. However, State agencies often carry out inspections in silos and refrain from sharing information with other Departments.
- 2. Hence, it is proposed to develop and implement a Central Inspection System (integrated risk based shared inspection system) covering Department of Industries and Commerce, Department of Labour and Employment and J&K State Pollution Control Board. Under the Central Inspection System (CIS) all the inspections prescribed under various Acts and Rules, as mentioned in Annexure-I, will be directly reported online by the Inspectorates to synchronize multiple inspections.

### The Inspection Framework:

- 3. The CIS online system will comprise of computerized list of units drawn from the Data Base of the Single Window Portal. The selection for inspection of an establishment would be done through computerized risk assessment. The risk levels will depend on sector, history of compliance, etc.
- 4. The list of industries to be inspected would be prepared in accordance with the set parameters based on which an inspection calendar shall be prepared. The compliance inspection shall be executed by respective Departments as per the schedule of inspection, allocation of Inspectors and subsequent intimations by the CIS online system.

### State Level Planning Committee (SLPC):

5. The policy matters with reference to the Central Inspection System shall be decided by the State Level Planning Committee (SLPC).

The Committee shall be a State Level Body mainly to implement advice, regulate and monitor the functioning of the CIS. The constitution of State Level Planning Committee shall be as follows:

The Committee may co-opt any other member or expert whenever required.

# Powers and Functions of the State Level Planning Committee

- 7. State Level Planning Committee will look after the broad policy and procedure of the CIS. The function of State Level Planning Committee will be as follows:
  - Design and develop online inspection system for scheduling of inspections.
  - ii. Establish framework for risk based inspections.
  - iii. The system shall further assign inspections automatically and shall allow online filing of inspections reports and generation of reports, if needed. It shall also support mobile and email alerts. Avoid multiplicity of inspections and inspectors.
  - iv. Allow Third party certification instead of Departmental Inspection depending on the risk assessment.
  - Decide quarterly plan for inspection by various concerned departments.
  - Review the functioning of the CI system and the performance of each office integrated in the CIS.

- vii. Mandating the surprise inspection(s) based on registered and recorded complaints are conducted with specific permissions duly recorded from the respective HODs.
- viii. Establish Helpdesk and Grievance Redressal Mechanism.

# Central Inspection Cell (CIC) in the Directorate of Industries:

- 8. The actual functioning of the Central Inspection System shall be carried out by a Central Inspection Cell (CIC). The CIC shall be headed by Director Industries and Commerce (concerned) who shall staff it adequately. Each participating Department will designate a Nodal Officer who shall be member of the Central Inspection Cell. The function of Central Inspection Cell (CIC) will be as follows:
  - To build capacity of the Inspectors by introducing training to enhance skill.
  - To introduce cross training of the Inspectors for different inspection to optimize use of resources.
  - iii. Develop modalities for conducting surprise inspections.
  - Monitor conduct of inspection reports.
  - Operationalization of Helpdesk and Grievance Redressal Mechanism.

## Risk Based Criteria for Inspections

9. Risk Based Inspection tool, where resources are focused on those enterprises carry a higher risk to the public is developed by the respective department. This risk based inspection tool shall form the basis to prioritize and determine the frequency of visit of each industrial establishment which shall form part of the annual inspection plans and detail visit schedule. The risk based schedule of the offices integrated in the JKCIS is as follows:

# a) J&K State Pollution Control Board

As defined by Government Order No 82-SPCB of 2018 dated 22-05-2018. Priorities of industries will be as follows:

### b) Department of Labour and Employment

As defined by Government Order No 56-L&E of 2018 dated 26-7-2018. For boilers, as defined by government from time to time.

The risk based inspection of the Labour and Employment department is as follows:
