Whereas, 160 kanals of land situated at Industrial Estate (Medicity), Rakh Gund, Aksha, Bemina, Srinagar, was allotted in favour of M/s Radiant Medicity, vide order No. SIDCO/ROK/2022/250 dated 14.07.2022 for Establishment of 150 Seats Medical College with 500 Bedded General Hospital; and

Whereas, in terms of Sub Clause 10.7, of the Jammu & Kashmir Industrial Land Allotment Policy 2021-30 issued vide Govt. Order No. 65-Ind of 2021 dated 24.03.2021, An allottee must pay 100% land premium within 60 days from the date of issuance of allotment letter and execute lease deed. However, allottee failed to deposit the due amount within 60 days & complete the necessary formalities; and

Whereas, in accordance sub-Clause 10.8.1 of the Jammu & Kashmir Industrial Land Allotment Policy 2021-30, statutory 30 days' notice vide No. SIDCO/EST/MECB/2022/120/1-4 dated 15-06-2023 was served upon the allottee with the request to deposit the payment and complete the requisite formalities; and

Whereas, in the interest of natural justice, final notice of seven (07) days was also served upon unit holder with the request to deposit the land premium and complete formalities, failing which it shall be presumed that unit holder is no more interested to set up your unit and the allotment order No. SIDCO/ROK/2022/250 dated 14.07.2022 shall be cancelled without further notice; and

Whereas, M/s Radiant Medicity, did not respond and had failed to deposit the due payment & complete the necessary formalities within the prescribed notice period; and
