The Government of Jammu and Kashmir has aspired to be the most favourable destination for investment across the country and to achieve the same, the Govt. of Jammu and Kashmir has initiated creation of a business friendly environment by Minimizing Regulatory Compliance Burden (MRCB) as part of Business Reform Action Plan.

To achieve the said goals, compliance inspections of all the eligible Industrial/ Business Units shall be made by Legal Mertrology Department as mandated under the J&K Central Inspection System.

For the purpose of registration/ licenses / renewals as well as Certificate of Verification of Weights and Measures of Industrial Units, the Legal Metrology Officers shall in the following manner carry out inspections alongwith other line department/s as mandated under J&K Central Inspection System:-

- All compliance based inspections under the Legal Metrology Act, 2009 and Rules made thereunder shall be carried out through the Centralized Inspection System (CIS) of the J&K single window system.
- Industries/business units that are eligible for compliance inspection shall be randomly selected for inspection.



- 3) Inspectors for Central Inspection System shall be allotted based on their jurisdiction and the same shall inspect Inspector not particular а industrial/business unit twice consecutively within a year.
- 4) Inspection report shall be uploaded online within 48 hours of the Inspection.
- 5) Inspection shall be limited to the points as required under Legal Metrology Act, 2009 and Rules made thereunder. The format of the inspection checklist along with the requisite procedure for the same can be accessed through the Departmental website http://www.jklegalmetrology.com.
- 6) Surprise Inspections/ complaint based inspections/ inspections permitted by the Controller shall be carried out under the general superintendence of the Controller, Legal Metrology J&K, as provided under the Legal Metrology Act, 2009.
