Whereas, in accordance to Clause 6 sub Clause 6.4 of Procedural Guideline to the Jammu & Kashmir Industrial Land Allotment Policy 2021-30 issued vide Govt. Order No. 120-Ind of 2021 dated 22.04.2021, 30 days notice was served upon party to deposit the payment and complete the requisite formalities. Additionally a notice of seven days & again a notice of five days was also served through e-mail.

Whereas a final notice of 15 days was published in newspaper in Jammu it was published in Daily Excelsior on 17-11-2022 & in Kashmir region it was published in Rising Kashmir on 15-11-2022 as well as notice was uploaded on the Single Window Portal.

Whereas, M/s BR Jindal Pet Industries Private Limited, have again failed to deposit the due payment & complete the necessary formalities within the notice period, even did not respond to notices issued by SIDCO.

Now therefore in terms of clause 10.8 sub Clause 10.8.3 of the Jammu & Kashmir Industrial Land Allotment Policy 2021-30 issued vide Govt. Order No. 65-Ind of 2021 dated 24.03.2021 and expiring of notice period with failure to fulfil the terms & conditions of the allotment, the land allotment order being No. SIDCO/ROJ/2021-22/84 dt. 18-02-2022 stands withdrawn and cancelled ab-initio.
